The main objective is to **enhance students' English language competence and legal English knowledge, enabling effective communication of legal arguments** and preparation for the TOLES exam. Additionally, students will develop skills essential for legal studies and participation in an American law school environment.

Program

► **The Practice of the law and the language of company law**

- Overview of regulatory systems, courts, legal practice areas, and adversarial vs. inquisitorial systems in the Anglo-Saxon world.
- Legal requirements for forming and managing companies, business terminology, and use of modal verbs in legal English.
- Company capitalization, shareholder rights, and roles of boards of directors.
- Legal processes for mergers, spin-offs, and winding-up; conducting AGMs and shareholder rights.

► **The language of contract law and employment law**

- Introduction to contract creation, negotiation techniques, and writing informative memoranda in English.
- Types of breaches, remedies, damages, and client correspondence, along with interview and argumentation techniques.
- Assignments, third-party rights, interpretation of clauses, and persuasion techniques in English.

- Labor law, including discrimination, dismissal, liability risks, and writing emails about with advantages or disadvantages and expressions of agreement or disagreement.

► **The language of sale of goods, real property law and IP law**

- Fundamentals of sales law, drafting sales contract clauses, terms and conditions, and retention of title, with oral presentation skills.
- UK and US property law, lease agreements, home sale contracts, easements, and terminology, along with oral presentation techniques and reference emails.
- Trademark and patent legislation, training junior lawyers, and English skills for paraphrasing, debates, and using speech markers.

► **The language of negotiable instruments, secure transactions and debtor-creditor**

- Promissory notes, bills of exchange, and regulations on electronic instruments; expressing legal advice and recommendations in English.



Program

- UK and US legislation on secured transactions, warranty agreements, and writing corporate emails with polite refusals and comparisons.
- Remedies for creditors and debtors, job opportunities in insolvency, and writing cover letters, thank you notes, and handling job interviews.

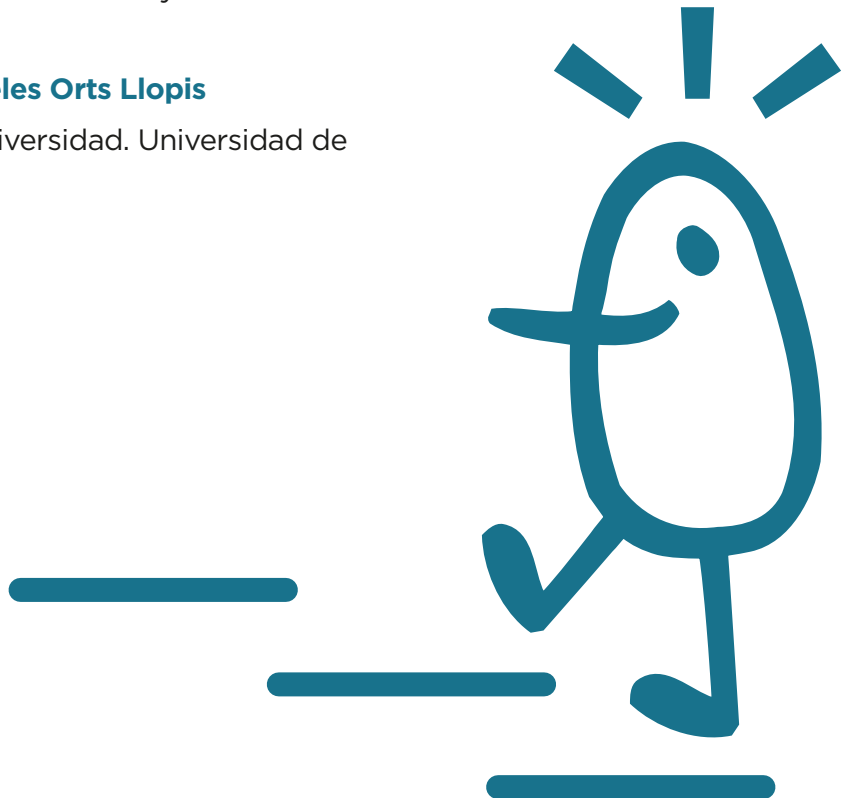
► **The language of competition law and international commercial law**

- Anti-competitive activities, cartel regulations, merger rules, writing informative emails, passive constructions, and giving legal opinions on competition cases.
- Transnational Commercial Law: Conflict of laws, ADR, international arbitration, and structuring letters, with presentations on cross-border disputes and terminology for cohesion.
